 - Review WEVD Road Map and pick a Road (section) to adopt.
 - The Adopters will email the Program Coordinator requesting their adopted Road or Road sections. The Coordinator will conform with the Road Adopter their Adopt Road (section) based on first notified.
 - Submit suggestions and comments to the Coordinator
 - Contact the Coordinator to join the Program committee
4. Program Coordinator(s) will maintain a data base of all Road Adopters with email address, signed Agreement date and Adopted Road and their condition notes.
5. The Road Adopter Volunteer safety is their number one priority. Please use caution when cleaning your Road.
6. The Program asks all Cleanup Volunteers to walk their Road during the Spring Cleanup Day, Columbus Day weekend or as needed.
7. Please send email to the Coordinator indicating date(s) of cleanup and other Road conditions.
8. Program Coordinator will give a Adopt A Road Program update to Corey, Judy and the Board in months of May and November or as requested.

VOLUNTEER SERVICE AGREEMENT

FOR PUBLIC, CHARITABLE OR RELIGIOUS FACILITIES ONLY

WATERVILLE ESTATES VILLAGE DISTRICT

This Agreement, made on _____ by and between the Waterville Estates Village District hereinafter referred to as "charity", and _____, _____ (*SSN*), _____ (*DOB*), hereinafter referred to as "volunteer."

WITNESSETH:

Whereas, volunteer intends to donate services to the charity identified above, and said charity intends to accept the donation of volunteer services.

NOW THEREFORE, in consideration of the mutual promises, the parties hereto agree as follows:

1. Volunteer agrees to donate services to charity in the capacity of _____ (*TITLE*).

Said services shall include, but may not be limited to, the following:

2. It is mutually and expressly understood that volunteer services shall be donated, and that said volunteer is not entitled to nor expects any present or future salary, wages, or benefits for these voluntary services.
3. Volunteer agrees to follow the supervision and direction of any personnel, employee, or volunteer, to whom volunteer had be assigned to perform services, and to participate in any training required by the charity in order to perform the voluntary services.

4. Volunteer agrees that he/she will not be considered to be an employee of the charity, for any purposes other than tort claims and injury compensation, while performing the above described voluntary services.
5. Volunteer further understands that if volunteer is responsible for injuries to third parties or damages to their property while acting outside the scope of assigned volunteer duties, that said volunteer may be held personally liable for any monetary damages a court may award to the injured party.
6. It is further understood and agreed to by volunteer that the services rendered to the charity shall apply only in the case of liability arising out of ordinary negligence the occurs during the scope of the volunteer's services agreed to herein, and that in no way do any of these provisions apply for the benefit of volunteer, his/hers heirs, executor or administrators in any action rising out of gross negligence, willful misconduct, or any other conduct on the part of said volunteer, which cause or may give rise to criminal liability.
7. Volunteer further agrees that volunteer will fully cooperate with the charity and its agents in any investigation, lawsuit, arbitration, or any other legal or quasi-legal proceedings that arise from the matters covered by this agreement. Volunteer further agrees to notify the charity immediately for any incident that occurs or may occur within the knowledge of the volunteer, which gives rise to liability on the part of the volunteer of the charity.
8. I understand that my volunteer assignment will begin on _____ and end on _____; and that I will spend approximately _____ hours per _____ providing volunteer services. I also understand that my volunteer assignment may be terminated at any time by either party to this agreement.
