The process, according to our By-Laws, for election of property owners to the Board of Directors has been initiated. There are **three (3)** vacant director positions.

There are two ways to become a candidate:

1. NOMINATION BY THE NOMINATIONS & ELECTIONS COMMITTEE – November 26, 2024

A committee of the Board of Directors has been appointed by the President of the Waterville Estates Association and charged with the responsibility for seeking out and identifying members in good standing who by background, experience, and dedication could contribute positively to the activities of the Board. The Committee must nominate at least one candidate for each of the three positions currently held by Directors whose terms are expiring. If you believe you are qualified to serve and are willing to make the significant commitment of time and energy that this position entails, you are invited to seek the endorsement of the committee by completing the enclosed form on page 2. WEA will perform a background check for candidates on our ballot. **Electronic submittal of candidacy is available below. Please include a brief statement of qualifications for the Committee's consideration and for transmittal by the Association to the voters. **The Committee asks that those seeking its endorsement include the following information about themselves: Name, WEA address, length of ownership, full-time or part-time residence (if the latter, frequency of visits to Waterville Estates), priorities for WEA, changes the candidate would like to see.** The Committee may, at its discretion, contact applicants for further information or it may seek to recruit additional candidates for its nomination. **The Committee will make its selections and notify all candidates by December 4, 2024.** Those candidates not nominated by the Committee may seek to have their names placed on the ballot by petition (see below).

2. NOMINATION BY PETITION – Due by December 10, 2024

To ensure that any member has the opportunity to run, regardless of the actions of the Nominations and Elections Committee, you may have your name placed on the ballot by petition. This petition requires the signature of not less than five members, who are owners at different addresses, of the Association who are in good standing, and no member may endorse more than one candidate for Director. If you are interested in filing such a petition, please use the enclosed blank form on page 3 for your convenience. **It should be printed, filled out and returned to the Nominations and Elections Committee at the above address no later than December 10, 2024.** Please include, on a single sheet of paper, your qualifications and information pertinent to your candidacy for transmittal by the Association to the voters.
